

Mysterious death of husband, wife and son in Surat

Surat, The mysterious death of three members of a family in Surat has raised suspicions of mass suicide. In this incident, the bodies of a husband, wife and son were found in different rooms of the house, following which the police have started an investigation.

The family had returned from a trip to Saudi Arabia just four days ago. The police are investigating the cause of death in this case.

The bodies of the three were found in different rooms. According to the details received, a family living in Haripura Sou Street in Lalgate area of Surat city has committed mass suicide. The husband, wife and son have died.

According to the police, the bodies of the three were found in different rooms. As soon as the incident was reported, the police reached the spot. The reason behind the suspicion of mass suicide is still unknown.

The family had returned from a trip to Saudi Arabia four days ago. 36-year-old father Faiz Ahmed, 32-year-old mother Mubina Ahmed and 13-year-old son Noman

Ahmed have died. The deceased family had returned from a trip to Saudi Arabia four days ago. They were involved in the chemical business. DCP Raghav Jain also reached the spot.

Tushar Ghelani pulled the trigger and the bullet tore through his head and hit the wall. The night of February 1st was a night of shock for the Ghelani family of Surat. Preparations for the wedding of their beloved daughter were underway in the house and mourning was over when Tushar Ghelani committed suicide with his own pistol, although many mysteries behind this suicide are still unsolved. He died on Thursday after a long five-day treatment. The police have seized the revolver and sent it to the FSL, however, a shocking fact has come to light that the revolver with which Tushar Ghelani committed suicide did not have a magazine, but he took his life with a bullet in the revolver's chamber.

On that dark night of February 1, family members and guests who had come to their home in the Citylight

area of ??Surat were discussing daughter Tanvi's wedding plans and the list of Kankoti. The Kankoti writing program was scheduled for the auspicious time on February 2 in the morning,

however, around 1 am, due to some personal reason or heartache, Tusharbai got agitated and went to his bedroom. On February 1, 2026, 44-year-old Seemaben Sunilbhai Vaghani swallowed

poison at her home. As soon as the incident was reported, she was immediately shifted to Venus Hospital and then to SIMS Hospital for treatment, however, she died after a short treatment.
